


The month of November 2017 was marked by the collaboration of several stakeholders including National Coast Guard, Mauritius Police Force, Ministries, NGOs and civilian population.



### 1.2.2.1 Speeches

#### (a) Address by Dr. Dhuneeroy Bissessur, General Manager of Beach Authority.

The General Manager welcomed and thanked everybody for their presence and collaboration. He pointed out that the Beach Authority was created under the Beach Authority Act 2002. Its mandate is to manage all proclaimed public beaches in Mauritius and Rodrigues Islands. There are 126 proclaimed public beaches in Mauritius and 12 in Rodrigues making a total of 138 proclaimed public beaches under the jurisdiction of the Beach Authority. The ultimate aim of the Beach Authority is to embellish, upgrade and to provide better access to our public beaches for the benefit of the beach users. The purpose of the event was to raise awareness and focus on our environmental vision for cleaner and greener public beaches for the benefit of one and all.

He also added that the public awareness campaign being carried out by the Beach Authority includes talks, distribution of pamphlets and plastic bin bags. Shortly, the awareness campaign will be carried out with all students starting with primary schools. Authorisation has already been sought from the relevant ministry.

The General Manager ended his speech by making an appeal to the public that the beach is our common area, together let's preserve it, respect it, keep it clean and healthy for the benefit of the present and future generations.
