INTRODUCTION


Public beaches are popular venues for recreation and leisure, in particular during the summer period in Mauritius.

1.0 Clean Up Campaign on public beaches in the context of 'End of Year Festive Period'

Clean Up Campaign on public beaches in the context of 'End of Year Festive Period' was carried out on four (4) public beaches namely Belle Mare, Mont Choisy, Flic en Flac and Gris Gris public beaches on **27 December**, **2018** in collaboration with several stakeholders with the objective to maintain cleanliness of our public beaches during the festive period, sensitise the public on the sustainable use of our beaches and vigilance/constant surveillance at sea.

The activities comprised of:

- Cleaning and embellishment of public beaches
- Symbolic tree planting exercise
- Sensitisation Campaign (distribution of flyers and plastic bin bags to beach users)
- Beach Patrol and Surveillance at sea by National Coast Guard

2.0 Post Cyclone "Cilida"

The island was under the influence of cyclone "Cilida" as from on Friday 21 December (16.00 hours) to early morning on Sunday 23 December, 2018.

A survey was carried out on all public beaches by staff of the Authority after the passage of the cyclone.

Observations:

It was noted that no major damages have occurred on our public beaches and beach amenities/infrastructure, except for accumulation of water/seaweeds, a few and fallen trees and some broken branches on certain public beaches (including at Poste Lafayette near SMF Memorial, Baie du Cap, P. G Bel Ombre, Mont Choisy amongst others).

Action taken:

Relevant scavenging contractors and the Field Services Unit of the Parent Ministry responsible for the day to day cleaning and maintenance of public beaches were requested to deploy additional resources for the removal and carting away of:

- (i) wastes (including debris, seaweeds)
- (ii) fallen trees and branches

3.0 Construction of Toilet Blocks at Pointe des Lascars public beach

Situated in the district of Rivière du Rempart and between Von Moltke and Poudre d'Or public beaches, the Pointe Des Lascars public beach has an approximate sea frontage of 176 metres over an extent on 0.5679 (Ha) and was proclaimed in year 2015.

Following request from local inhabitants, the Beach Authority has embarked on the construction of a new toilet block, with a view to provide better facilities to beach users, under Financial Year 2018/2019.

The works started on 18 July, 2018 and have been completed on 24 December, 2018.

4.0 Construction of Toilet Blocks at Rivière des Galets public beach

New toilet blocks with associated amenities and facilities have been constructed at Rivière des Galets public beach with a view to provide better facilities to beach users.

5.0 Upgrading of Toilet Blocks at Trou aux Biches (in front of Police Station) public beach

Trou aux Biches (in front of Police Station) public beach is considered as one among the best public beaches in Mauritius in terms of its sand quality as well as its weather conditions.

With a view to providing better facilities to beach users, the existing toilet blocks thereat have been upgraded.

6.0 Supply and Installation of Picnic Tables on public beaches

The supply and installation of fifty (50) picnic tables on twenty-one (21) public beaches are ongoing. The picnic tables are made of 100% recycled plastic materials which is durable and provide attractive sitting areas. Recycled plastic picnic tables will not rot, warp, splinter or crack and increases their overall longevity ensuring that they will look great for the years to come. The picnic tables can accommodate about 4 to 6 persons at a time. The works are expected to be completed by mid-January, 2019.

7.0 Provision of Lighting Facilities through PV Solar Panels on public beaches

Enhancing safety and security on public beaches remains a priority at the level of the Beach Authority. Subsequently, solar lighting systems, which are more reliable and cost effective, are gradually being installed to phase out conventional lighting systems on public beaches. The works have been completed and handing over and commissioning will be carried out by mid-January, 2019.

8.0 Installations of Litter Bins on public beaches

Although all the public beaches in Mauritius have litter bins that are serviced on a daily basis, the majority of beach users dispose of their rubbish responsibly, nevertheless, there are still some who leave their litter behind.

One of the objectives of the Beach Authority is to sensitise beach users in keeping the environment clean and to dispose their wastes in a proper manner.

As an ongoing project, eight (8) litter bins have been placed at Pomponette public beach during the month of December, 2018.

9.0 Replacement and Installation of new Open Showers at Pereybère public beach

The Pereybère public beach is amongst the most prized public beaches by tourists as well as locals inhabitants and is particularly lively during this festive period. The public beach is famed for its white fine sand and crystal-clear waters. The Beach Authority has constructed open shower which would allow beach users the benefit of running in and out the open shower together with the ease of quick access.

13.0 Crackdown Operations on public beaches

Crackdown operations on public beaches are regularly carried out in collaboration with the Mauritius Police Force with a view to prevent tampering/illegal connection of electricity, illegal trading and to verify the state of the public beach.

Crackdown operations were carried out at Mont Choisy, Trou aux Biches, La Cuvette and Flic en Flac public beaches.

Contraventions established:

Four (4) contraventions were established for the following offences:

- (i) Three (3) contraventions for 'Driving motor vehicle on public beach' at Mont Choisy public beach
- (ii) One (1) contravention for 'Trading without licence' at Mont Choisy public beach

Observations:

The public beaches and toilet blocks were kept clean and found to be up to the standard.

14.3 Upgrading of Commercial Building at Blue Bay public beach

Upgrading works of tuckshop at Blue Bay public beach is ongoing and expected to be completed by mid-January, 2019. The works consist of:

- Repair of door locks
- Repair and maintenance of electrical and plumbing
- Removal of existing tiles and replacing by new anti-skid ones
- Provision of aluminium openings
- Provision for waste water disposal
- Provision for sheltered roof and veranda
