





14.0 Upgrading of Belle Mare Public Beach in collaboration with Mauritius Prison Service

A Memorandum of Understanding for the upliftment of Belle Mare public beach was signed on 14 September 2016 between the Mauritius Prison Service and the Beach Authority.

The upliftment of Belle Mare public beach project has been developed under the scheme "Pay Back Mauritius" whereby detainees are given the opportunity to make reparation for the harm they have done through their offending. The aim is to utilise the resources of the prison system, detainee skills and labour towards a worthwhile community project, thus the upliftment of Belle Mare Public beach. The project also provides opportunities for detainees to develop necessary skills so that they may gain employment upon release, thus contributing to the economic well-being of the community.


In order to keep pace with the growing demands of the public, the Beach Authority will be establishing 3 new sub-offices at Belle Mare, Flic en Flac and Blue Bay public beaches to provide a better service delivery.

With a view to enhance further waste management and keep the beaches cleaner, the Beach Authority will install several bins including two hundred (200) along the Western Coast of Mauritius.

The support of stakeholders is being sought to enable the Beach Authority to continue in its everlasting quest for clean-up and embellishment of all proclaimed public beaches thus ensuring a cleaner, greener and safer environment.
